Jewish Population in the United States, 1981

SUMMATION OF LOCAL ESTIMATES for the number of persons in Jewish households in 1981 totals 5,921,000, virtually identical with the estimate for 1980. The Northeast and Northcentral states accounted for 68.5 per cent of the total population, compared with 68.9 per cent last year and 72.2 per cent five years ago. Of the 21 states in these regions, only five showed population increases over 1980. The South and West comprised 31.5 per cent of the total, compared with 31.1 per cent last year and 27.8 per cent five years ago. Eleven of the 30 states (including the District of Columbia) in these regions reported population increases.

Local Jewish population estimates are provided primarily through an annual survey of Jewish federations. Some communities revise estimates annually, while others report changes incurred over a longer period. The degree of accuracy of any one figure is related to the method of estimation. Formal population studies are conducted by some communities, while others estimate roughly on the basis of lists of known Jewish households.

Approximately five per cent of the total Jewish population resides in non-federated communities. An attempt to contact each of these communities, usually through a local synagogue, is made every three years.

Whatever method of estimation is employed, the primary unit of count is the household, which must be multiplied by an estimated household size to provide the population figure. In the absence of detailed data on individuals, the definition of a Jewish household is one which contains one or more Jews. This definition results in the inclusion of some non-Jews in the population estimates provided by reporting communities. Applying the 1970 National Jewish Population Study (NJPS) estimate of the number of non-Jews in "Jewish households" to the current U.S. figure, we arrive at a count of 5,500,000 Jewish members in "Jewish households."*

The U.S. Census Bureau does not identify Jews as an ethnic group and therefore does not collect data on Jewish populations. The Bureau's annual reports on changes

*The national estimate of Jewish members in Jewish households derived from the 1970 NJPS data can vary somewhat depending on different assumptions dealing with non-respondents. The article on "World Jewish Population" in this volume derives a higher estimate based on a different set of premises.

in general population numbers are based on birth rate, death rate, and net migration figures. The first two elements are not available for the Jewish populations from any official source. While migration estimates are available for Soviet Jews and Israelis, the latter, in particular, are difficult to define and may include a substantial temporary resident population. For these reasons no attempt has been made by the authors to develop overall population trends similar in method to the Census Bureau's projections.

The Greater New York Metropolitan area figure, currently estimated at more than one-third the total Jewish population of the United States, represents the greatest source for potential modification of the national total. A figure of 1,228,000 for New York City proper, based on the 1970 NJPS, is almost certainly overstated. The magnitude of the population shift to New York City suburbs and to areas outside Greater New York is unknown. The problem is further compounded by lack of current estimates for the areas contiguous with Metropolitan New York, i.e., Rockland County in New York State and Bergen County in New Jersey. A study sponsored by the New York Federation of Jewish Philanthropies, which will help to resolve these questions, is now underway.

National, regional, and state totals, shown in Tables 1 and 2, are derived by summing the local community estimates. While these totals are presented, it should be emphasized that they are reported only as estimates. State totals exclude duplicate listings and out-of-state figures, where a community extends across state boundaries. Communities with less than 100 Jews (not shown in Table 3) are also included, as is an estimate for unreported Jews (generally in areas having no local synagogue). The latter figure is put at 25,000, or less than one-half of one per cent of the national total. This figure is calculated by doubling the number of Jews in communities reporting less than 100 Jewish residents.
